1 About SupplyOn Product Footprint

What does the PRODUCT FOOTPRINT solution do?

The SupplyOn Product Footprint solution enables the exchange of sustainability related product data such as Product Carbon Footprint between supplier and customer.

2 Getting started

Login to SupplyOn and click in the navigation bar on SupplyOn Services and select Product Footprint. You will be directly taken to the Service Dashboard.

2.1 Role and Company Administrator

Before you can use the Service Product Footprint, your Company Administrator must assign you one of the following roles for Manufacturing & Visibility.

PF Admin: Management master data. Administration of users. Evaluation of parts and suppliers along the lifecycle of a part

PF Controller: Calculation, processing, management and analysis of requests, CO2 data and KPIs. Release and withdrawal of new CO2 data to customers. Evaluation of parts and suppliers along the lifecycle of a part.

PF Sales Key Account Manager: Management and analysis of requests, CO2 data and KPIs. Release and withdrawal of new CO2 data to customers. Evaluation of parts and suppliers along the lifecycle of a part.

3 Dashboard (under development)

The dashboard is still under development and will be available at a later stage.

The dashboard contains 9 visualization cards as follow:

1. **PCF expiry date:**

The PCF expiry date feature exhibits the forthcoming expiration dates for each part. The user can view the upcoming expiration dates divided into three expiration date categories. The first range displays dates within the next 30 days, the second displays dates ranging from 31 to 60 days, and the third ranging from 61 to 90 days.

2. **Parts per status:**

By using this graph, users can monitor the number and percentage of parts sorted according to their status.

3. **Requests per due date:**

The diagram is sectioned into three distinct segments, each with its own color-coding. Due dates with fewer than 10 days remaining are indicated in red, those between 10 and 20 days will be highlighted in orange, and those ranging from 20 to 30 days are marked in yellow.

4. **Table of parts:**

The parts table displays the "Part Number," "Description," and "Valid Until." Supplier users can track the "Requested by" column to identify the requester.

5. **Verification status:**

This doughnut chart displays the distribution of validated data per part. It is divided into four sections: "not verified," "only PCF calculation verified," "only PCF value verified," and "both verified." The user can view the share of each section.

6. **Table of requests:**

The presented table exhibits the "Request Name" and "Due Date." Supplier users can observe the "Requested by" column to identify the creator of the request.

7. **Primary Data Share (PDS):**

This doughnut chart illustrates the average distribution of Primary Data and Secondary Data.

8. **Share of secondary raw material:**

This chart shows the share of Primary and secondary raw material on average.

9. **Share of recycled material:**

This chart shows the share of raw materials and recycled materials on average.

4 Actual Footprint

In the Actual Footprint section, data on the currently valid carbon footprint is requested. The fields may differ depending on the business division or/and product.

4.1 Request Overview

In this view you will see the tabs (1) Requests (sorted by requests) or (2) Requested parts (sorted by requested parts). Click on the (3) request name to open the request.

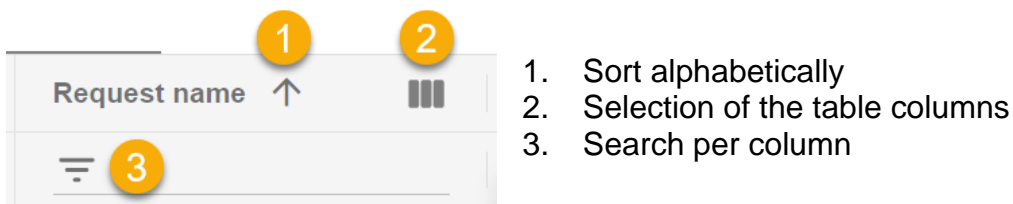
There are three additional fields in Planned Footprint. Start of Production (SOP) refers to the year that the product was planned to be manufactured. “Years from SOP” represents the number of years from the start of production that the customer requests for Product Footprint data.

6 Status Overviews

- Completed:** The request has been completed.
- Accepted:** Customer has accepted the request
- Closed:** Request was closed by your customer
- Rejected:** Request was rejected by the customer / customer called back the request
- Won't do:** Supplier rejects the request / cannot complete the request

9 Glossary

Product Carbon Footprint (PCF)	The complete greenhouse gas emissions produced throughout the entire life cycle of a product, usually measured in CO ₂ e. However, emissions related to the use and end-of-life stages of the product are not included in the PCF (see Catena-X PCF Rulebook).
Actual Footprint	A process stream for the parts that are already sourced and produced.
Planned Footprint	A process stream for parts that are still within the RFQ and sourcing process.
PCF Scope 1	Scope 1 emissions are direct GHG emissions that occur from sources that are owned or controlled by the reporting entity. Examples of scope 1 emissions include emissions from combustion of fossil fuels in boilers, furnaces, vehicles, or other equipment owned by the company.
PCF Scope 2	Scope 2 emissions are indirect GHG emissions that result from the consumption of purchased electricity, heat, or steam by the reporting entity.
PCF Scope 3	Scope 3 emissions are all other indirect GHG emissions that occur in the value chain of the reporting entity, including emissions from the production of purchased goods and services, employee commuting, and waste disposal.
CO ₂ e (Carbon dioxide equivalent)	A unit that measures the radiative forcing of a greenhouse gas in comparison to carbon dioxide.
Declared unit	The amount of a product that is used as a standard unit to measure a partial PCF.
Greenhouse gases (GHGs)	A gas present in the atmosphere, both from natural and human activities, that absorbs and emits radiation within specific wavelengths of the infrared spectrum emitted by the Earth's surface, atmosphere, and clouds.
Primary data	Primary data refers to the quantified value of a process or activity that is obtained through direct measurement or calculated using direct measurements. This may include greenhouse gas emission factors or data related to greenhouse gas emissions.
Secondary data	Secondary data refers to information obtained from sources such as databases, published literature, national inventories' default emission factors, calculated data estimates, or other trustworthy data validated by relevant authorities.
Biogenic Carbon	Carbon derived from biomass.

**Start of
Production (SOP)**

The year scheduled to produce the part. For instance: 2023.

Years from SOP

The duration for which the buyer requires their suppliers to provide their Product Footprint evaluation. For instance, 4 means that the supplier shall provide the PCF estimation for the following years:

1. SOP+1 year (for example 2024)
 2. SOP+2 year (for example 2025)
 3. SOP+3 year (for example 2026)
 4. SOP+4 year (for example 2027)
