

CCF survey 2024 Printable questionnaire

This table gives you a preview of all the questions you'll find in the survey:

- Please note that the questions starting with: *if "..."* will only appear based on how you answered a previous question. All questions that follow from the same preceding question are arranged vertically in the table to show their connection. For example, the questions "2023: Do you have separate data for scopes 1 and 2?" and "2023: gross global Scope 3 upstream emissions (metric tons CO2e)" will only appear if you answered "Yes" to the preceding question, "Do you have corporate carbon footprint data for 2023?".
- The "Field Data Type" column specifies the type of answer expected for each question. Be sure to check whether the expected input is a whole number (integer) or a decimal number.
- For Checkbox and Dropdown questions, the "Dropdown Menu Options" column lists the possible choices.

Important Note for Decimal Numbers: When entering decimal numbers, please use a point (.) as the decimal separator. If the field requires a decimal number and you need to enter an integer, be sure to add ".0" to the value (e.g., enter "5.0" instead of just "5").
