

Quick Guide - Air Supply Concession

The aim of this quick guide is to give you a basic overview about AirSupply Concession, to explain how you can request a user account and how to enter the application.

1 Basic Knowledge about AirSupply Concession

A concession (NCR) is a written permission to use or release a nonconforming material, meaning a material that does not conform to the specified customer requirements.

A concession request is a workflow in AirSupply, which allows a supplier to request the permission to deliver the non-conformed material.

2 Prerequisites for the usage of AirSupply Concession

Precondition for the usage of AirSupply Concession is an active user account for the AirSupply platform with the appropriate user roles for AirSupply Concession.

To receive an appropriate user account please contact your internal AirSupply **CompanyAdmin** and request at least one of the following user roles for Concession:

- > IndSellerConcession-Write
- IndSellerConcession-Read

Airsupply Company Admin

- Your AirSupply CompanyAdmin is an employee of your company
- If you don't know your CompanyAdmin please contact the <u>SupplyOn Support</u> (Please provide your company name and your Supplier Number or DUNS)
- Your AirSupply CompanyAdmin is responsible for:
 - Creation of user accounts
 - Assignment of additional user roles
 - Resetting of your password
 - Unlocking your user account

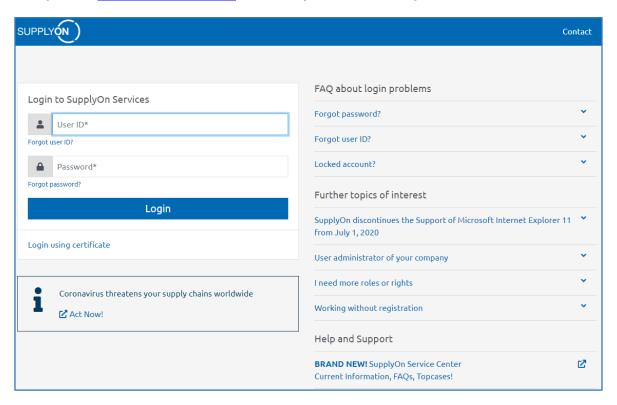

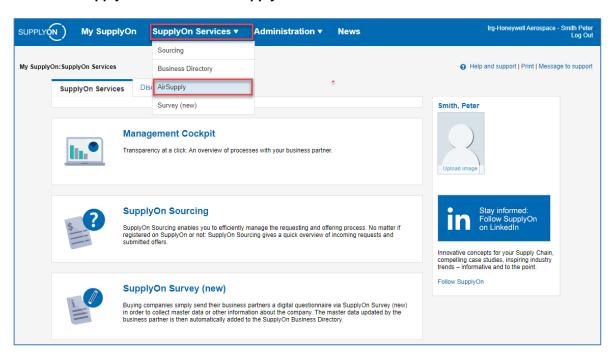


4 How to start the creation of a Concession request

4.1 Open the SupplyOn Login Page and enter your User ID and password

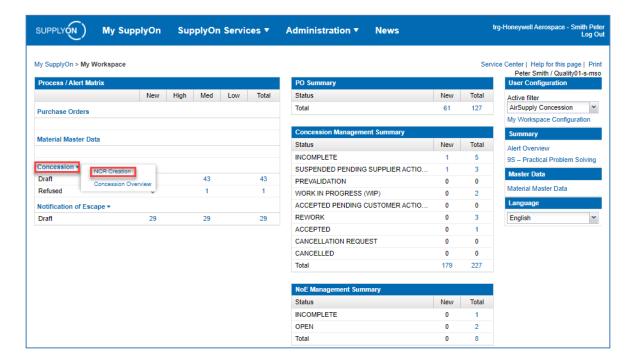


4.2 Select SupplyOn Services > AirSupply





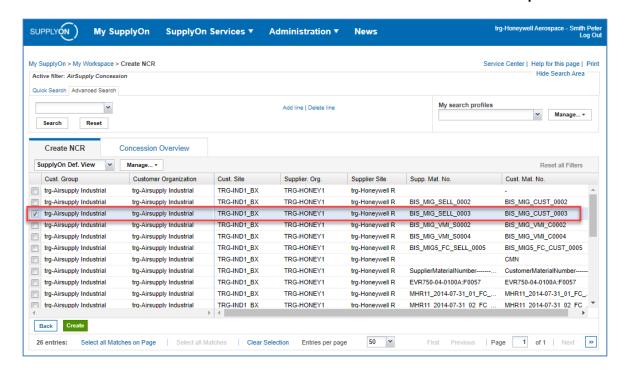
4.3 Select Concession > NCR Creation



Note

If the link for *Concession* is missing in *My Workspace* your AirSupply user account didn't get assigned the necessary user roles for Concession. Please see the necessary preconditions in chapter 2.

4.4 Select the affected material and confirm with Create to start the Concession process





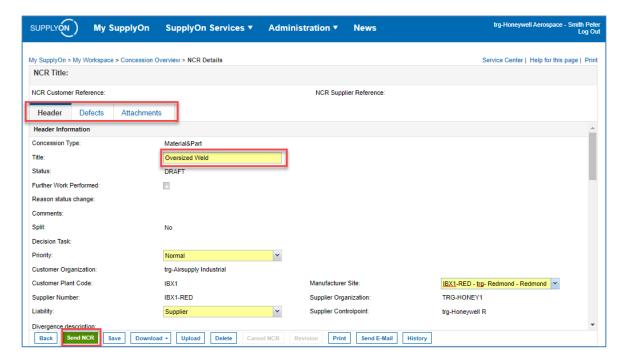
Note

If the affected material you need to create the Concession request for, is not available in the list, please use the dedicated dummy material number "-" (Cust. Mat. No) to start the process.

If the concerned material is available more than one time in the list, please consider to which customer plant the material was delivered.

By clicking Create, the Concession request is firstly created as a Draft. You are still able to delete it, without sending it to your customer.

4.5 Fill in all necessary fields in the NCR Details and send the Concession request to your customer



Note

Your customer now reviews the information provided and decides how to proceed with the nonconformity.

Different statuses of your concession request show the current processing level.

It may occur that your customer requests additional information (status Incomplete). In some cases, it may be necessary to confirm the execution of a requested rework (status SPSA).
